Question 1

We already have security clearance in progress, but we haven't received it yet. Are we allowed to participate in this RFP?

Question 2

We would like to ask if there is an incumbent who was/is performing the requested services.

Question 3

Refer to pages 70-72, Point Rated Technical Criteria of the Backup Chief S&T Advisor. The resource must score a minimum of 60% of the points for 4.1, 4.3, and 4.4 (10 points each, of which 60% totals 18/30 points) as well as score a minimum of 40/50 points for 4.2. Please confirm that the total minimum points the propose resource must meet is 58/80

Answer 3
