### **Amendment 015**

This amendment 015 is raised to provide questions and answers.

#### **Question 1:**

If a call-up request is received to provide a service, can the Supplier reject that request due to unavailability of equipment?

#### **Answer 1:**

Unexpected circumstances such as unavailability of equipment sometimes happen, and are understandable. However, the listed supplier must prepare well and get ready to receive call-up, and make every effort to provide service.

If Identified Users are rejected by one supplier repeatedly, they may choose not to consider that supplier for all other future service requests.

If a supplier is found unavailable many times, its standing offer may be suspended.

#### **Question 2:**

With regards to article 6B.2.3 Value of the Goods, do you need this information when we submit an offer or when a service request is received from one of the departments?

#### **Answer 2:**

The information to above article must be included in the offer submitted by the Offeror.
