AMENDMENT 002

This amendment to the solicitation is raised to answer bidder questions and to amend the solicitation document.

Canada does not intend to grant extensions for the bid solicitation period.

BIDDER QUESTIONS

Q15: Could DND please confirm that bidders can propose resources that hold either a Government Canada Reliability Status or Secret Clearance?

A15: See answer to Q7, amendment 001.

Q16: Referring to Web Designer requirements RC3 and RC4 and Programmer Analyst requirement RB4: could DND confirm that one certification in one of the listed technologies is considered equivalent to two years of experience with that technology, which means it would only count as 1 point, and does not replace experience with all technologies (would not count as full points)?

A16: Correct. In RC3 and RC4 certification with any of the listed technologies, or at least one (1) year of experience with that technology within the specific timeframe, will be worth one (1) point. In RB4 certification with any of the listed technologies, or at least two (2) years of experience within the last ten (10) years with that technology, will be worth one (1) point. To earn additional points requires certification or experience in additional technologies.

Q17: Given the complexity of the corporate requirements and the upcoming holiday season during which many resources have reduced availability to provide requisite grid substantiation details, we respectfully request a two week extension to January 21, 2020.

A17: Canada does not intend to grant extensions for the bid solicitation period.

Q18: Could DND confirm that they will accept a Bachelor of Engineering (B.E. electronics) from the University of --- in India, a recognized University, for M1 in the Business Analyst grid?

A18: Please see Section 3.2 (a) (v) of the Request for Proposal. The academic credentials requirement for the Business Analyst (MD1) includes "A degree from a recognized university in any field". If this university is recognized then any degree they issue would be acceptable.

Q19: Would the DND client team consider extending the RFP deadline 1 week to January 1th as the majority of staff are unavailable to contribute to a response between December 20th – January 6th in consideration of the holiday vacation schedule at this time of year. This 1 week extension would allow us the necessary time to provide a RFP response it was detailed as per the appropriate standards of DND and procurement response best practices.

Q20: Would the crown consider extending the deadline for this RFP to January 16th due to the Holiday Season and a lot of candidates not being available at this time.

Q21: As per Section 1.2a, we understand this is a re-tender of solicitation #W6369-190169/A. Would the Crown please explain why the solicitation was re-tendered?

- A.13 Web Designer (LEVEL 2) requires Enhanced Reliability clearance
- B.1 Business Analyst (LEVEL 3) requires Secret clearance
