SECTION A - QUESTIONS AND ANSWERS

Question 3

In regards to Solicitation W8486-207077/A (SOCEM RFI), the industry day planned for January 29th causes a scheduling conflict in the industry, specifically for companies involved in designing and manufacturing rucksacks. As can be expected, military rucksacks share similar technologies and supply chains with the backpacks of the outdoor sports industry. A major event in that market, the Outdoor Retailer Show in Denver, CO, will take place January 29th-31st, 2020. We have plans to attend this event, and suspect that a number of other companies interested in participating in a subsequent tender will also attend the event. We suggest moving the Industry Day to the following week, between February 3rd and 7th. Moving the Industry Day a week earlier is not a good option, since another major event in the industry, the SHOT Show in Las Vegas, NV, takes place January 21st-24th and industry professionals will attend this one as well.
