Is it possible that the required foam for the backpacks at ANNEX A REQUIREMENT, subsection 4.2.2 - Foam Insert for Backpack Specifications, must be polyethylene instead of polyurethane, as “closed cell polyurethane foam” is not available, however “closed cell polyethylene foam” is available?

Yes, the foam must be made of Polyethylene and not Polyurethane. The RFP has been amended to correct this specification.
