PART 1 - GENERAL INFORMATION

1.1 Security Requirements

There is no security requirement applicable to this Contract.

1.2 Requirement

The requirement is detailed under Article 6.2 of the resulting contract clauses.

1.3 Debriefings

Bidders may request a debriefing on the results of the bid solicitation process. Bidders should make the request to the Contracting Authority within 15 working days from receipt of the results of the bid solicitation process. The debriefing may be in writing, by telephone or in person.

1.4 Trade Agreements

The requirement is subject to the provisions of the North American Free Trade Agreement (NAFTA) and the Canadian Free Trade Agreement (CFTA).

1.5 epost Connect service

This bid solicitation allows bidders to use the epost Connect service provided by Canada Post Corporation to transmit their bid electronically. PART 2 - BIDDER INSTRUCTIONS

2.1 Standard Instructions, Clauses and Conditions

2.3 Enquiries - Bid Solicitation

All enquiries must be submitted in writing to the Contracting Authority no later than seven (7) calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by Bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the question(s) or may request that the Bidder do so, so that the proprietary nature of the question(s) is eliminated, and the enquiry can be answered to all Bidders. Enquiries not submitted in a form that can be distributed to all Bidders may not be answered by Canada.

2.4 Applicable Laws

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in British Columbia.

Bidders may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their bid, by deleting the name of the Canadian province or territory specified and inserting the name of the Canadian province or territory of their choice. If no change is made, it acknowledges that the applicable laws specified are acceptable to the Bidders.

PART 3 - BID PREPARATION INSTRUCTIONS

3.1 Bid Preparation Instructions

If the Bidder chooses to submit its bid electronically, Canada requests that the Bidder submits its bid in accordance with section 08 of the 2003 standard instructions. The epost Connect system has a limit of 1GB per single message posted and a limit of 20GB per conversation.

Canada requests that bidders follow the format instructions described below in the preparation of hard copy of their bid:

If the Bidder is simultaneously providing copies of its bid using multiple acceptable delivery methods, and if there is a discrepancy between the wording of any of these copies and the electronic copy provided through epost Connect service, the wording of the electronic copy provided through epost Connect service will have priority over the wording of the other copies.

4.2 Basis of Selection

ANNEX A – REQUIREMENT

Objective

Department of Fisheries and Oceans Canada (DFO) has a requirement for one (1) maintenance shed that will provide a fully covered work area for personnel to work on two Zodiac Hurricane 753 rigid hull inflatable boats (RHIB) inside, which will be backed in and out of the structure on trailers. The shed will be a portable, prefabricated unit that will be at a fixed location at DFO's location at the Institute of Oceans Sciences.

Specifications

The maintenance shed will be exposed to sun, wind, rain, snow, and ocean water salt spray. The shed requires solid sides and a solid roof to provide shelter from wind, rain, snow, and salt spray. The structure of the shed will be secured to the pavement with anchor bolts through flanges welded or fastened to the bottom of the frame. The shed requires two (2) overhead garage doors on both the front and back of the structure with a minimum size of 4.3m x 4.3m (14' x 14'), for a total of four garage doors, and two (2) lockable, steel side door for people to enter and exit. The exterior of the structure must be constructed from galvanized steel. The photo below indicates the position of the double garage doors (A and B) and the steel side doors (C and D), as well as the approximate site location at the Institute of Ocean Sciences:



Requirements

The supplier must provide the maintenance shed in accordance with the mandatory technical criteria contained in Annex "D".

The maintenance shed must be delivered and assembled to the delivery address noted in Annex "B".
