This amendment is raised to:

- A) respond to questions submitted by Industry.

A. Questions and Answers:

Q1. Can the Crown confirm that, as per the last Standing Offer, only eight (8) firms will be retained for Fairness Monitor Services?

A1. It's Canada's intention to issue Standing Offers to any Supplier who meets the requirements of the RFSO.

Q2. We noticed that a refresh solicitation will be posted every eighteen months.

a. Can the Crown confirm that existing suppliers who were retained will not be eliminated if they fall outside the 140% median clause?

b. Can the Crown confirm that any newly qualified suppliers added to the list of suppliers during a refresh period will be ranked at the end of the Supplier list (i.e. after existing suppliers who have been previously qualified)?

Q3. We noticed that, since the last Standing Offer was issued, the position of Team Leader has been eliminated. Can the Crown please provide the methodology to ensure the Quality Assurance Review to be undertaken by the Crown / Suppliers for upcoming FM services?

A3. The quality of deliverables submitted under any resulting Standing Offer is the responsibility of the Offeror.

Q4. Can the Crown confirm that suppliers must be able to meet the minimum level of Secret for document safeguarding to ensure proper delivery of services to the Crown?

A4. Security requirements are stated in Part 6 - Security, Financial and Insurance Requirements, and Part 7 - Standing Offer and Resulting Contract Clauses.
