AMENDMENT 002 IS RAISED TO ANSWER QUESTIONS TO THE SOLICITATION.

Q.01: Q1. Will the shipping location be able to accommodate a 53 foot trailer for the delivery of the goods? If not, what is the maximum truck length the location is able to accommodate?

A.01: Yes, the location can accommodate a 53 foot trailer.

Q.02. As there is no freight elevator available, will stair carry be involved?

A.02. No, the unit is on the end of the ground floor, there is no loading dock or freight elevator. The only step is from the curb to the sidewalk into the unit.

Q.03. NSA 2, fixed Height Work Surface Laminate 2 Full gables with modesty panel 18"D x 48"w x 29"h:

a. There is a quantity of 2 of this item on the floor plan, but the bid has a quantity of 1. Please confirm.

A.03.a There is only one of these tables in the work area labeled 001f. The other table has a different tag (T-1848) and forms part of category 6.

b. Is the height of 29" correct as they are for a soft seating area?

A.03.b This area is a work surface and needs to be 29" high.
