Questions:

Question 1:

We feel the statement below could be taken in two ways, can you confirm that we are to put a price in the box for our applicable trades and for non-applicable trades we are to put a 0 dollar value or N/A, OR is the statement telling us to put in a price for our applicable trade and entering any other markups in non-applicable boxes will disqualify our bid?

10. Offerors shall complete Table B below by inserting the requested all-inclusive fixed hourly rate (in Can \$). Failure to provide the Journeyman rate or to enter « Not Applicable (N/A) » or to enter a \$0.00 rate will render the Offer non responsive.

Answer 1:

There can be no non-applicable trades. The bid has to be for all the trades listed in para 3 of the Statement of Work. All fields in the Table A Percentage Offer and Table B Hourly Rate must be completed. If a bid is not submitted for all the trades listed, it will be non-responsive.

Question 2:

Can you please clarify if standing offers are issued per a trade basis or must you perform all services to be awarded?

Request for standing offer 4.2.1 states "...offers for all the trades. The two (2) responsive offers with the lowest evaluated price...."

Yet

Slide 16 from Amendment 1 (pdf page 16) states "can be for an individual trade or combine several"

Answer 2:

CFHA is in the process of establishing 40 Standing Offers at 22 Housing Services Centres. Some of the SO are for an individual trades, and some are for a combination of trades. For example, in Comox SO #W3705-21CX01/A is for a combination of trades whereas W3705-21CX02/A is for an individual trade. The required trades are listed in para 3 of the Statement of Work.

The intent of the RFSO W3705-21CX01/A is to award two Standing Offers to the two highest ranking Offerors to perform the services under all the trades listed in para 3 of the Statement of Work. The bid has to be for all the trades listed in para 3 of the Statement of Work. If a bid is not submitted for all the trades listed, it will be non-responsive.

The Call-ups will be issued such that the highest ranked Offeror will perform the majority of the work. Canada may offer work to other than the highest ranked Offeror when, in the opinion of Canada, scheduling of work and / or, Offeror availability and / or, Offeror workload would dictate such distribution.
