We've been doing the bulk of the CFHA maintenance work at Greenwood for nearly 25 years, since inception. However, the Public Works tender form requirements seem daunting... Perhaps I'm reading too much into it...

Could you give me, via email, an overview of what is actually required with the tender submission?

**Answer 1:**

The submission is detailed in the RFSO PART 3 - OFFER PREPARATION INSTRUCTIONS

The offer must be gathered per section and separated as follows:

**Section I: Technical Offer**

In their technical offer, offerors should explain and demonstrate how they propose to meet the requirements and how they will carry out the Work.

In their technical offer, offerors should demonstrate how they meet the mandatory technical criteria listed in the Attachment 1 to Part 4 Technical Criteria.

**Section II: Financial Offer**

Offerors must submit their financial offer in accordance with the pricing schedule detailed in Attachment 1 to Part 3.

**Section III: Certifications**

Offerors must submit the certifications and additional information required under Part 5.

**Section IV: Additional Information**

In Section IV of their offer, offerors should provide:

1. their legal name;
2. their Procurement Business Number (PBN);
3. the name of the contact person (provide also this person's mailing address, phone and facsimile numbers and email address) authorized by the offeror to enter into communications with Canada with regards to their offer, and any contract that may result from their offer;
4. for Part 2, article 3, Former Public Servant, of the Request for Standing Offer: the required answer to each question; and, if the answer is yes, the required information;
