Question 5:

There were some low res files supplied on the tender, would it be possible to get a sample of a high res file?

Response 5:

Question 6:

In regard to the resolution of the actual print image. Will the files be supplied as 300 DPI or 600 DPI or 1200 DPI?

Response 6:

The high resolution files that will be provided to the Contractor will be 300 DPI.

Question 7:

Is there an opportunity to reduce the size of the Xplorer and Club Parka to 13.5 x 8.5 folding to 6.75 x 7.5? This would save a substantial amount on the costs of the printing.

Response 7:

No. The booklet size cannot be reduced.
