Question #001:

Due to the holiday season and the level of details required, would Canada please consider granting an extension of two (2) weeks?

Answer #001:

Canada grants an extension of the bid closing date. The new bid closing date is **March 03, 2020**. Please note, Canada has no intention to further extend the bid closing date.

Question #002:

On page 15 of the RFP, Part 6 – Security, Financial and Other Requirements, item (c) under Subsection 6.1.1 it states, “The Bidder’s proposed location of work performance and document safeguarding must meet the security requirements as described in Part 7 - Resulting Contract Clauses.” Can the Crown please confirm our interpretation that the work to be performed within this mandate is to be done “offsite” at the Bidder’s location. Furthermore, if so, will the Crown accept the document safeguarding requirements to be in process at the time of contract award in order to allocate for the time required to complete the formal document safeguarding process of securing a separate workspace?

Answer #002:

As per Annex A – Statement of Work, 3.9 Additional Requirements, ADDR.07 the Business Partner must support various worksite arrangements that may include, as a minimum:

- a) On-site with GC employees and/or with GC partners;
- b) Off-site from the Business Partner’s facility; and
- c) Combination of a) and b).

The worksite arrangements will be specified within each TA.

Should the successful Bidder not meet the security requirements at the time of contract award, their bid could be deemed non-compliant. As per Subsection 6.1.2 under Part 6 – Security, Financial and Other Requirements, “Any delay in the award of a contract to allow the successful Bidder to obtain the required clearance will be at the entire discretion of the Contracting Authority.”

Can Canada confirm (and name) that contract holders (and any subcontractors) of the CDS and IPMRS requirements as well as those listed under 1.4.2 in the RFP are excluded from bidding on the Business Partner Services RFP?

Answer #003:

Canada confirms that the CDS Technology Partner, IPRMS Technology Partner and their subcontractors are precluded from bidding on the solicitation of the Business Partner Services (BPS), either as a sole Bidder, Joint Venture or subcontractor to the Bidder.
