**This amendment is issued to make the following changes:**

**On page 3 of 93**, add “1.2.4 - The Federal Contractors Program (FCP) for employment equity applies to this procurement; refer to Part 5 – Certifications and Additional Information, Part 7 - Resulting Contract Clauses and the annex titled Federal Contractors Program for Employment Equity - Certification.”

**On page 6 of 93**, delete “2.7 - Mandatory Site Visit” in its entirety and replace with the following:

**2.7 Mandatory Site Visit**

It is mandatory that the Bidder or a representative of the Bidder visit the work site. Arrangements have been made for the site visit to be held at CFB Edmonton Clinic, Building 417, Vimy Avenue on 21-Jan-2020. The site visit will begin at 13:30 MST in the reception area.

Bidders must communicate with the Contracting Authority no later than 20-Jan-2020 at 14:00 MST to confirm attendance and provide the name(s) of the person(s) who will attend. Bidders will be required to sign an attendance sheet. Bidders should confirm in their bid that they have attended the site visit.

Bidders who do not attend the mandatory site visit or do not send a representative will not be given an alternative appointment and their bid will be declared non-responsive. Any clarifications or changes to the bid solicitation resulting from the site visit will be included as an amendment to the bid solicitation

**On page 17 of 93**, add “7.9.3 - Federal Contractors Program for Employment Equity - Default by the Contractor”

The Contractor understands and agrees that, when an Agreement to Implement Employment Equity (AIEE) exists between the Contractor and Employment and Social Development Canada (ESDC)-Labour, the AIEE must remain valid during the entire period of the Contract. If the AIEE becomes invalid, the name of the Contractor will be added to the "[FCP Limited Eligibility to Bid](#)" list. The imposition of such a sanction by ESDC will constitute the Contractor in default as per the terms of the Contract.

**On page 19 of 93**, in “Annex A - Statement of Work” under “References”, add the following:
