#### Amendment 004

This amendment is raised to answer questions from bidders

#### A. Questions and Answers

- Q1) Alberta Transportation does not have an approved round post, are these intended to be Gardner Post or another type. Could a spec sheet be provided for the Sign Posts required for this project?
- A1) The sign posts are intended to be wood post. Please see revisions from Amendment 3.
- Q2) Do the permanent traffic signs need to be powder coated Parks Canada Green on the back and sides?
- A2) No, Refer to Specifications Section 10 14 53 2.1.2
- Q3) Alberta Transportation requires signs on highway 16 to be oversized. Are these signs within the parks boarders also required to be oversized?
- A3) They are not required to be oversized.

#### Unit Price Table - Bid Item 1 – Asphalt Removal a) Partial Depth Milling - 6,600 M<sup>2</sup>.

- Q4) The drawings show a 50mm mill and inlay (min 0.5m wide) for the length of the widening. This would be approximately 2,135 m x  $0.5m = 1,067.5 M^2$ . Where is the remaining quantity of asphalt removal (6,600 1,067.5 = 5,532.5)?
- A4) Refer to IFT drawing Sheet C101 to C 104 for extent of mill and inlay area.
- Q5) Spec 02 41 13 section 1.2.2 Measurement and Payment Procedures says payment per M<sup>2</sup> for asphalt removal is the same for partial or full depth. Could this item be made into 2 bid items, one for partial removal of 50mm, and one for full depth removal up to 400mm?
- A5) No.
- Q6) If sawcutting of asphalt is required for asphalt removal, how will this be paid?
- A6) No sawcutting is expected. If sawcutting is required by the departmental representative, it will be paid under Lump Sum item 3 Prime Cost Sum.

#### <u>Unit Price Table - Bid Item 4 – Roadway & Drainage Excavation a) Stripping for Disposal &</u> <u>Waste Excavation - 8,980 M<sup>3</sup></u>

- Q7) Could you provide a breakdown of how much of this quantity is stripping and how much is waste excavation?
- A7) Refer to design cross sections and Specifications Section 31 24 13 1.3.
- Q8) Does Parks Canada have a disposal site for waste excavation onsite or does it all have to be hauled off site?
- A8) Refer to Specification 31 24 13.

#### Unit Price Table - Bid Item 7 – Pavement Parking a) Line Painting

- Q9) Spec 32 17 23 section 1.3.4 Measurement and Payment Procedures says Removal of Existing Lines is Incidental. Could you provide a quantity of line removal that will be required on this project (it is not clear on the drawings)?
- A9) Refer to IFT drawing Sheet C101-C104 and C401-C402 for extent of existing paint line removal.

- Q10) Spec 32 91 19 section 3.3 Screening of Stripping Material states that the stripping material is to be screened. Will we be required to screen the topsoil prior to placing it?
- A10) The requirement for screening has been removed from the specification. Please see revisions from Amendment 3.
- Q11) The Dates identified in Specification 01 14 00 Article 1.4.2.6 do not accurately correlate to 2020; please amend appropriately.
- A11) Article 1.4.2.6 has been revised. Please see revisions from Amendment 3.
- Q12) Specification 01 32 16 Article 1.2.4 defines the Work Week as Monday to Saturday; please confirm if Contractor is not permitted to work Sundays
- A12) Please see revisions from Amendment 3, Specification 01 14 00 1.4.1
- Q13) On drawing C302 there are two culvert details supplied. To which installation do these culvert details apply?
- A13) Refer to IFT drawing Sheet C101, C103 for culvert replacement and extension locations.
