Amendment 006 is issued for the following:

1. Bidder Question & Answer

Question: 28

The list “Treasury Board Appendix L, Acceptable Bonding Companies” all relate to insurance companies. Would it not be possible to use a major German bank instead?

Response: 28

The only acceptable bonding companies are those identified at section 2.30 of the solicitation document.

Question: 29

Regarding the business number – wouldn't it be possible to use our German business number instead of the Canadian, since all works are taking place outside of Canada?

Response: 29

The only acceptable business number is the Canadian issued Procurement Business Number, as identified in Section 2.2 of the solicitation document. This number can be obtained after the solicitation process, but must be obtained before a contract is awarded.

Question: 30

Regarding the existing furniture there seem to be contradictory information. As of now, the 4 rooms are equipped with a standard equipment free of charge. And everything beyond this is extra – if there is a monopoly or not is unclear. So we would, at any rate, just offer the “add-ons”. I believe that would be in the interest of Canada as well. I am waiting for a list with the existing materials and if you want to, I can send it to you.

Answer: 30

The bidder should not assume that office and conference room furniture at Messe Frankfurt is available to the Guest of Honour country free of charge. As outlined in D 2.1, f) – *Functional and Space Requirements Report* and D 2.3 – *Furniture and Storage Requirements Report*, the successful bidder will be required to assess, review and recommend the office furniture requirements based on the list provided in Addendum B 2.9.1 *Office Equipment*.

For the purpose of the financial submission, bidders should assume all equipment will need to be rented, and if required, work with the appropriate contractors exclusive to both Messe Frankfurt and the Frankfurt Book Fair.

A list of existing materials from Messe Frankfurt or the Frankfurt Book Fair is not required for this tender process.

All other Terms & Conditions Remain the Same
