Question:

Question 1 :

Are the contracts always paid by hourly rates for contractors? what if you want to work faster to complete the job quickly so you can start another job can you charge double time or time and a half

Answer 1:

The hourly rates only apply in certain situations and is not the default basis of payment for the work performed.

The scope of work in each call up will be identified through the Schedule of Unit Rates as listed in Appendix 5 and supported by Appendix 6 Schedule of Unit Rates Specification and the Statement of Work. Each SUR price (the base price adjusted by the bidders' percentage) includes labour, time, travel, material, plant, fuel, overhead, wastage and profit. When SURs are used to call up the work, the hourly rates do not apply.

Only if the work cannot be identified through the Schedule of Unit Rates, CFHA can authorize work by providing the general work description. Hourly rates will apply as per Annex B, Basis of Payment, of the Standing Offer. Also, hourly rates will apply when the Contractor is expressly directed to carry out emergency work outside the normal working day. Please refer to clause 8.6.5 and 8.6.6, and Annex B Basis of Payment for details.
