#### **Amendment 001**

This amendment is being raised to distribute the answers to bidder questions and extend the solicitation closing date.

#### A. BID CLOSING DATE

The closing date for tender 5P420-19-0314/A is extended from January 21, 2020 to **January 28, 2020 at 2:00PM Mountain Standard Time (MST)**.

#### B. QUESTIONS AND ANSWERS

Q1 Is video/time lapse photography part of the work?

A1 Video/time lapse photography is not currently in the project scope of this solicitation.

**Q2** In reference to: "Appendix 2 – Integrity Provisions" (13/24); and "Providing the required names is a mandatory requirement for award of a contract or real property agreement.", please clarify is this a Mandatory Requirement at the time of bidding or only prior to award.

**A2** The list of names described in Appendix 2 – Integrity Provisions must be provided prior to contract award by the successful bidder. Bidders are encouraged to provide this information with their bid submission, although failure to provide it with a bid submission will not result in a bid being deemed noncompliant.

Q3 Under SI08 Insufficient Funding, in reference to "...Bidders shall retain the same subcontractors and suppliers...", we believe that PCA will understand that this can only be reasonable if the award following "negotiations" or "re-bid" remains within the Bid Validity Period from the original bid closing date. Please confirm.

A3 All options outlined within SI08 would be invoked within the Bid Validity Period.

**Q4** Under SI10 Construction Documents, in reference to: "Obtaining more copies will be the responsibility of the Contractor including costs." Please indicate what are the costs and if those costs are limited to the cost of printing additional copies.

**A4** Electronic copies will be provided to the successful contractor. Obtaining paper copies will be the responsibility of the contractor.
