Amendment 002

This amendment modifies the RFP and provides responses to bidder questions.

1. Bidder questions and Canada's responses:

Q1: At Annex A, Appendix 2 Phase 1 & 2 hours do not add up as follows:

Phase one has modules A,B & C equaling 5,160 minutes, Phase two has modules D,E & F equaling 7,025 for a total of 12,185 hours. However, in the detailed breakdown Phase one has modules A,B & C equaling 4,985 minutes and Phase two has modules D,E & F equaling 7,770 for a total of 12,755 hours. Please confirm which total is correct.

R1: Please use the detailed breakdown total of 12,755 hours.

Q2: Are bidders permitted to propose subcontractors to meet the requirement and qualify under the mandatory and rated criteria?

R2: Under this RFP subcontractors must be equally qualified to meet the solicitation, security and contract requirements and in accordance with the General Conditions 2035 06 (2013-06-27) the use of subcontracts by bidders require that the bidder obtain approval of the Contracting Authority prior to submitting a proposal.
