**2. Question and Answer:**

Question 1:

In PART 3 under Section II :Financial Offer, it states “The total amount of applicable taxes must be shown separately.”

1. Where should they be shown? I assume not in the Appendix B1 spreadsheets.
2. What taxes should be shown? Federal, provincial, or both?

Answer 1:

Bidders must show the Goods and Services Tax/Harmonized Sales Tax (GST/HST) separately in the bid/offer/arrangement. They must also indicate whether their items are fully taxable, zero-rated, or exempt (see [Annex 4.4: Supplies Exempt from Goods and Services Tax/Harmonized Sales Tax](#)), and must show into which category each item falls.
