AMENDMENT 003

The purpose of this amendment is the following:

- 1) Extend the closing date of the Request for Proposal to January 30, 2020.
- 2) Provide questions and answers along with amendments to the Request for Proposal document.

Question 1:

I have a question regarding the base weight on the grader:

In your amendment 9 Graders you state that the base weight must be 19,200KG base operating weight with no additional equipment.

Unless the weather station is looking for a Cat 14 sized grader is it possible the weights are still being based on graders typically equipped weights published in brochures which includes ripper/pushblock?

Answer 1: The total mass in operation corresponds to that published in the documentation by suppliers with standard equipment. According to the brochures, John Deere 670G and higher and Caterpillar 140 and higher would be compliant.

Question 2:

The SSVD block in stainless and reusable stainless fitting cannot be supplied as described
If you want stainless it would be non reusable and difficult to repair on site it takes a hydraulic press.

Answer 2:

Stainless steel is required only for hose attachments (fastening) with protection for hoses.

Standard SSVD grease block and fittings must be reusable. Stainless steel for these parts has not been requested.

Question 3:

3a: Refer to Product #1 Technical Specification, Item 17.3: could you please accept Selected idle adjustment from 900–1,250 rpm?

Delete Section 17 of Product #1 and insert the following:

3b: Refer to Product #1 Technical Specification, Item 46.11: could you please accept 8 amp voltage convertor?

Delete Section 46 of Product #1 and insert the following:
