REQUIREMENT

1.0 Scope

1.1 Objective

To acquire new linen for Tribute Tower, to be used by accommodations in the residence dormitories.

For the purpose of this document, the term "Linen" will encompass the following;

- Comforters
- Fleece Blankets
- Flat Sheets
- Pillow Cases
- Quilted Mattress Covers
- Fitted Sheets

1.2 Background

Tribute Tower is a residence building which houses personnel while on training, in support of the Canadian Armed forces, servicing primarily Canadian Forces Base Halifax and surrounding areas. Replenishing/acquiring new linen ensures all rooms are being properly outfitted and ensuring sufficient accommodations for day to day use.

1.3 Intended Use

Procurement of new linen will ensure that Tribute Tower is stocked at all times to accommodate husbandry duties, scheduled laundry times, replacement of soiled sheets, high volume course turnover and generally deal with the transient nature of the building

2.0 Scope of Requirements

2.1 The vendor must supply linen that meets all the requirements identified within this SOR.

4.2 The vendor must ensure all linen being shipped is in good form, that all boxes are properly labeled with the correct quantities, with no discrepancies.

4.3 The style and type of Comforters must be the following in the residence dorm: reversible, premium polyester 6 oz or higher filling. Color of the comforters must be Navy Blue on both sides, any shade will be accepted

4.4 Due to the wear and laundering of the sheets, the thread count cannot be lower than 180 for the following items;

- Comforter
- Double Fitted Sheet
- Double Flat Sheet
- Pillow Cases

4.5 Fleece minimum requirements are as follows;

280 GSM thickness with Premium Polyester Fiber Construction, Anti-pilling and Brushing on both sides

4.6 A two (2) inch variance will be accepted on the dimensions of the following:

- Comforters
- Fleece blankets
- Flat Sheets.

A variance will not be accepted on the Double Fitted Sheets and Double Mattress Cover sizes referenced in Annex A, as they have been measured for proper fitment.

Question 1: Referring to Annex A, section 3.1, item #2, is tan an acceptable colour for the fleece blankets?

Answer 1: No. As per annex A, acceptable fleece colours are brown, grey or navy blue.

Question 2: Referring to Annex A, section 3.1, item #6, are the mattress covers to be fitted (contoured) or flat with anchor bands?

Answer 2: The mattress covers are to be fitted (contoured)

Question 3: Can you confirm that the flat and fitted sheets have the same size?

Answer 3: No, the flat and fitted sheets have different dimensions as seen in the chart as it has been amended

Question 4: Do samples of products need to be submitted with the bid?

Answer 4: No.

Question 5: Will linen sizes other than the ones listed in Annex A be considered?

Answer 5: A two (2) inch variance will be accepted on the dimensions of the following:

- Comforters
- Fleece blankets
- Flat Sheets.

Question 6: Are pillow cases to be standard single or standard double size?

Answer 6: Pillow cases are to be standard single.

Question 7: What material should the sheets and pillow cases be made of?

Answer 7: All sheets and pillow cases should be made of 50% cotton and 50% polyester.

Question 8: What material should the mattress covers be made of? What should the mass weight be?

Answer 8: Polyester top and bottom, quilted with polyester filling with a minimum mass weight of 3oz per square yard.

Question 9: Do pillow cases need to have a minimum thread count?

Answer 9: Yes, pillow cases are required to have a minimum thread count of 180, as per Annex A, section 4.4.
