AMENDMENT No.3

THE PURPOSE OF THIS AMENDMENT IS TO GIVE EFFECT TO THE FOLLOWING CHANGE;

Questions and Answers #1

1. Could you please clarify the Consultant Team Requirements for this RFSO? Under Section 3.2.2 and 3.2.4, one of the key personnel is identified as a Senior Geotechnical Engineer. However, the Consultant Team Identification table in Section 3.1.4 does not reference a senior geotechnical engineer, but rather asks to identify a senior and intermediate environmental scientist. Can you please confirm the project team requirements and the five key personnel to be identified for this RFSO?

Answer: Table 3.1.4 should reference Senior Engineer and Intermediate Engineer instead of Senior Civil Engineer and Intermediate Civil Engineer. Thus Civil, Environmental and Hydraulic Engineer are covered under the terms Senior and Intermediate Engineers shown in Table 3.1.4. Revised Table 3.1.4 shown in addendum 2

2. Senior Geotechnical Engineer is missing from table 3.1.4 of Part 6 – Submission Requirements and Evaluation (SRE), but is mentioned in Section 3.2.4 under item #2. Should this be included in the table 3.1.4?

Answer: See answer above

3. Senior Site Inspector is listed in table 3.1.4 and Senior Site Supervisor is listed under the key personnel, are these to be taken as the same role or should the Senior Site Supervisor be included in the table?

Answer: Senior Site Supervisor listed under key personnel in clause 3.2.2a should ready Senior Site Inspector, yes, these are the same role. See addendum 2 for revised clause 3.2.2 a.

4. The number of points for 3.2.3 and 3.2.4 of Part 6 does not match the weighting factors/ratings in the table provided in 3.3. Point total of (30) for 3.2.3 and a point total of (20) for 3.2.4, table indicates weighting rating of 0-35 and 0-25, respectively. Please indicate which point values shall be followed?

Answer: Please see amendment #2.

- 5. There are some discrepancies between the TOC titles and the title headings in the body of the document for Part 5 Standing Offer Brief. Which heading shall be followed when responding to the RFSO?
 - a. Ex: TOC section 8 reads, "Construction Document Services (RS4)" and document heading reads, "Construction or Design-Build Document Services RS4".

Answer: Please see amendment #2.

6. As per section 3.1.4 Consultant Team Identification and Experience, role #6 Senior Env Scientist identifies that the minimum experience is a P.Biol or a B.Sc. in Environmental Science within minimum 15 years of directly related experience. Would other designations with related experience be considered? We have a senior environmental professional with nearly 20 years of env experience with environmental education and a bachelors' degree, as well registered as an Environmental Professional with EcoCanada.

Answer: Requirements for Environmental Scientist to bachelor's degree and 15 years of directly related experience for Senior position, and 10 years of directly related experience for Intermediate position. Please see amendment #2.

7. Can you provide a detailed description for the difference between a Field Clerk and Site Supervisor/Site Inspector (see question 2)?

Answer: The Site Inspector is defined under resident engineer in clause 10.9, Field Clerk will include weigher, checker etc. see addendum 2 for revisions to section 10.9 and table 3.1.4.

8. Can the proponent submit the same personnel for multiple of the senior personnel roles and project personnel roles indicated in table 3.1.4?

Answer: Yes, provided they have all of the requisite experience

9. Are all the key personnel listed under 3.2.4.2 required to be in-house (or JV), or can one or more, such as the landscape architect, be from a sub-consultant?

Answer: Landscape Architecture may be a sub-consultant, all other consultants must be in-house or joint venture.

10. Please provide a 7 (seven) day extension to review answers to questions?

Answer: Please see amendment #2.
