## **QUESTIONS AND ANSWERS:**

Question 1	There is no reference to a procurement vehicle on the RFP. Please would you clarify which procurement vehicle the Crown intends to make use of for these services?
Answer 1	This is an open bidding solicitation, we are not using a procurement vehicle.

Question 2	Will the proposed resources be required to meet any additional requirements (for example THS stream requirements) not specified in the RFP?
Answer 2	Proposed resources must only meet the requirements identified in the RFP.

Question 3	We would like to know if we can bid on this RFP under just one stream: English editing. As experienced editors, it is our strong recommendation that IRCC consider contracting the editing and writing portion of the work to a firm expert in that one particular field.
Answer 3	IRCC's work requirement includes the successful bidder providing French language editing, as well as being able to provide side-by-side comparisons and edits between the English and French documents. The final products are IRCC's Parliamentary reports, which must be completed in both official languages.
