Letter of Interest (LOI)/Request for Information (RFI)/B amendment no. 002 is raised to answer questions submitted by the industry as follows:

### **Question 1**

We are confused with the statement indicating DRAFT on each document. Does this imply that there will be further rounds of submissions subsequent to the RFI closing date?

#### **Answer to question 1**

As indicated in the RFI/B, Canada is issuing these draft documents publicly on the BuyandSell website to ensure Canada benefits from industry feedback prior to finalizing the final RFP package.

### **Question 2**

Can you also confirm whether we need to make another submission under this RFI/B, in order to qualify for the formal RFP when issued?

#### **Answer to question 2**

Any interested Bidder will be eligible to bid on any subsequent RFP.

### **Question 3**

MR-6A Maximum Draft of 4.7 meters, does this include an azimuth thruster forward when deployed if so fitted?

#### **Answer to question 3**

The 4.7m maximum draft must include a bow thruster or its equivalent (e.g.: a deployed forward retractable azimuth thruster).

### **Question 4**

MR-8A Freeboard no greater than 1.8M at maximum draft. Is this freeboard measure from the main deck or from the top of bulwark/crash rail? IE is the requirement to have a clear opening over the vessel side of no great than 1.8 to the water?

#### **Answer to question 4**

The 1.8m freeboard is from the main deck.

### **Question 5**

MR10A Vessel must have accommodation for 20 crew. Are their limitations/preference on berth arrangements? IE Single Berth versus Multiple Berth Cabins.

#### **Answer to question 5**

A specific arrangement of the 20 berths is not mandatory, but please note that the rated criteria RR-4A is meant to reward proposed vessels that will accommodate the maximum number of single berths post conversion.

MR22A Vessel must be less than 25 years old at closing of the RFP. Is there a projected time line for an RFP and a closing date for same?

### **Answer to question 6**

For clarity purposes see changes to MR-22A:

MR-22A	The Bidder's Vessel must be 25 years old or less as of April 1 <sup>st</sup> , 2020.	The Bidder must provide a Certificate of Classification that demonstrates that the year of build is less than or equal to 25 years as of April 1 <sup>st</sup> , 2020.

### **Question 7**

MR-30A Vessel must not have fuel tanks in direct contact with the outer hull. Does this include all hydrocarbon tanks or just fuel tanks? IE If a vessel has an IACS Member Clean Notation would this be acceptable?

### **Answer to question 7**

For clarity purposes see changes to MR-30A:

MR-30A	The Bidder's Vessel must not have hydrocarbon tanks in direct contact with the outer layer of the hull.	The Bidder must provide an as-fitted tank arrangement drawing that demonstrate the separation between hydrocarbon tanks and the outer layer of the hull.
