Solicitation Amendment No. 03

This solicitation is also hereby amended to provide the following questions and answers:

Q1. Under section 5 of Annex A, "Extended Warranty", three years extended warranty is requested. Are you looking for 3-year extended warranty to be paid in total upfront at the time of equipment purchase? Or are you looking for an annual payment after the expiry of one year standard warranty? Please clarify.

A1. We are looking at three years extended warranty to be paid up front with costs included in the all-inclusive fee as stated in annex B – Basis of Payment (*Firm all-inclusive lot price in Canadian funds including Canadian customs duties, excise taxes, DDP destination, delivery, installation and training.*).

Q2. Security Requirements, There is no security requirement applicable to the Contract.

Can you please elaborate on this? Will Field Service Representatives be required to complete a security clearance form in order to perform service on the equipment?

A2. Contractors are not required to complete security clearance forms to enter the correctional institutions in order to perform service on the equipment. A date to perform service on the equipment is agreed upon with the delegated authority, in this case the Chief of Health Services, and from there a list of tools that will be brought in to provide the service will have to be submitted along with the name of the technician, prior to the visit. The technician will have to provide appropriate identification at the entrance and have the toolkit submitted for a search. The technician will be escorted by a Correctional Service Canada employee or a Commissionaire upon entry and for the duration of the work performed on the equipment and then escorted back to the exit where the toolkit will be searched again
