Amendment no. 001 to provide a response to questions raised to date and to extend the bid solicitation closing date and, as follows:

- Q1 The bid solicitation is in PDF and the Attachment 2 of Part 3 is a fillable PDF form. For the technical section and financial section, does the Bidder answer the questions in these sections in Microsoft Word or Excel? Or is there another fillable form?
- A1 Bidders can submit their bids in any format, Attachment 2 to Part 3 is the only fillable form for this bid solicitation. Bidders can submit their bid electronically using the epost Connect service provided by Canada Post Corporation or electronically on a CD/DVD to PWGSC's Bid Receiving Unit or in hard copy to PWGSC's Bid Receiving Unit.
- Q2 In terms of the selection process, is there a score that is given to the technical section or does the Bidder need to meet 100% of the technical requirements and only when a Bidder meets 100% of the technical requirements will the Bidder's financial bid then be considered? If a Bidder fails to meet all of the technical requirements, is the Bidder's bid declared non-responsive without Canada evaluating the Bidder's financial bid?
- A2 No, there is no score that is given to the technical section, a Bidder must meet all of the technical requirements before Canada would consider evaluating the Bidder's financial bid. Yes, if a Bidder fails to meet all of the technical requirements, the Bidder's bid is declared non-responsive and Canada will not evaluate the Bidder's financial bid.
