A) Question and Answer

Q1: In Annex A – Requirement, section 3.1 iii the requirement states “Must be able to create and save inspections with specific parameters, downloadable with administrative rights”. Is the requirement to allow data, setup, parameters, etc. to be fully accessible or is there a different requirement?

A1: The requirement is to develop Non Destructive Testing inspections with specific setup, parameters, etc., save them within the system and place administrative rights on those NDT inspections so that certain parameters can only be changed by those who have administrative rights.

Q2: In Annex A – Requirement, section 3.1 / xiii. / (b): what does the number ‘39’ stand for?

A2: ‘39’ is a typographic error. It is to be removed.

Q3: In Annex A – Requirement section 3.2 / ii. / Please confirm the mechanic of the probe? Would it be a flexible PCB (**ECA I-Flex probe**) or padded on (**ECA padded probe**), see below.

Q5: In reference to the RFP sections 6.5.2 Project Authority and 6.5.3 Contractor's Representative, who is referred as Project Authority and Contractor's Representative? **Is this person a representative from our company?** Does the Project Authority refer to a Product Manager? As per Contractor's Representative, does this refer to a Sales Manager or to someone at higher level in the company's management hierarchy?

A5: Only the Contractor Representative and applicable information is to be filled by the bidder to identify a representative from the bidding company.

Q6: The Tender has been released in English and French language. Do we have to submit simultaneously tender reply in English as well as in French or the bidder selects the language to submit only one bid response?

A6: The tender reply (bid) can be in either English or French only.

Q7: In Reference to Article 2.2 titled Submission of Bids on page 3 and 4, there is a reference to Facsimile number: 416-952-1256. Can we also submit our bid response by fax?

A7: Bids by facsimile (fax) are acceptable for this tender requirement.

Q8: On bid first page, it says that the Delivery terms are FOB destination. Are other terms such as FCA or DDP acceptable?

A8: FOB destination is the only acceptable delivery term specified in the tender document.

Q9: Article 6.4.3 titled "Option to Extend the Contract" says that the Contractor grants to Canada the irrevocable option to extend the term of the Contract by up to __Four (4)____ additional __One (1)____ year period(s) under the same conditions.

Does this refer to Software subscriptions and/or to the technical support, and warranty?

A9: The option to extend refers to each of Software subscriptions, technical support, and warranty.

Q10: We have a question related to article 6.4.3 titled "Option to Extend the Contract".

It says "to extend the term of the Contract by up to __Four (4)____ additional __One (1)____ year period(s) under the same conditions". What is the meaning of the terms "under the same conditions"? Is it referring to offer the same product solution than the one quoted this year for an additional 4 years or is it referring to other conditions to be maintained for additional 4 years such as product warranty, technical support, pricing etc.? Please, note that our product prices are updated every year.

A10: This is in reference to the terms and conditions in the contract in general, which carry over into any option period, if invoked.

 - e. Instrument familiarization of all features (interface, settings, scanning and acquiring data);
 - f. Setting and saving parameters to create inspection setups;
 - g. Practical experience with non-ferromagnetic test samples; and
 - h. In-depth data analysis and generating reports.

3.3.2 Training must be coordinated between ATESS/NDTC/DS Project Authority and Contractor prior to delivery of system, and must be conducted between one week prior and up to three weeks after receipt of system.
