This amendment is issued to provide responses to the following questions received:

- Q1. Is the Red Cross instructor wording missed in 5.3.1 as both the St John's and Red Cross instructor is included in 5.3.2? As we are a Red Cross provider now, and teach both courses, I believe that St John's will not accept the Red Cross BLS provider certificate. Or do we have to have 2 different instructors certified in 2 first aid corporations?
- R1. For the BLS we will accept either St. Johns or Red Cross certifications.
- Q2. For 5.2 page 20 of 35, is this flexible on the manufacturer of equipment in the ambulance as we do carry Stryker products but also have Ferno stretchers in some of our 4x4 ambulances?
- R2. Yes, Ferno stretchers would be permitted.
