The following changes in the Tender Documents are effective immediately. This addendum will form part of the Contract Documents.

Answers to questions received from Bidders:

Questions received January 17th, 2020:

1. As already mentioned, we need architectural demolition plans. The info provided on the M&E plans is not sufficient.
Answer: Demolition has already been undertaken separately as there was abatement work required. When you attend the job showing, this will be apparent.
2. Detail 6 on page A-100 shows note 9, but that is apparently an error, please confirm.
Answer: please refer to the revised drawing A100, appended.
3. Specifications index for division 26 seems to be missing the details. It shows pages numbers but not the sub sections.
Answer: Specifications Index clearly lists all sections for all Divisions.
4. Please confirm the structural plan scope. It seems to be shoring a single core hole and recommended reinforcement for it, then tells you to refer to electrical where I see no info on why that core hole is needed, nor the size and location. Please clarify.
Answer: the structural work is limited to coring for electrical.
5. What ceramic tile size will be needed, requested?
Answer: Travertine floor tiles are to be 305mm x 610mm (12" x 24").
