1. Bidder's Question:

Drawing ID-111 states 'Smoke Baffles to be maintained in good condition'. Drawing ID-151 states 'new baffles to replace existing' as well as 'existing smoke baffle to remain in good condition, clean glass.' Could you please clarify whether new smoke baffles are required?

.1 Answer: Remove note 'new baffles to replace existing' from drawing ID-111. Baffles to remain intact to grandfather existing conditions. Cleaning is required.

**REFER TO SPECIFICATIONS: Section 12 24 13 – Roller Shades**

1. Bidder's request to use Elite Z-Series roller shade:

.1 Answer: This specification is performance based. So long as options in line with the specification are used, it may be considered. Shop drawings detailing specific options will need to be provided at shop drawing stage for review upon award.

.1 Note the square facia profile may be used so long as it is able to be mounted within the mullion area as required and is available in the Espresso or Black colourways.
