The following changes to the Request for Information (RFI) are effective immediately.

Amendment 003 is issued for the following reasons:

- (1) Publish a supplier's question and the answer hereto; and
- (2) Amend attachment ABES.PROD.PW__BM.B030.E27579.ATTA002.PDF (draft Request for Proposal (RFP)) to the RFI.

(1) Supplier's Question and Answer

Question #2:

We have a question that we would like some clarification on please.

The clauses within the draft listed below would appear to exclude any product that is not produced in Canada from being able to enter into this competition. Can you please provide a clear definition of those two sections.

1.2.3 The requirement is subject to a preference for Canadian goods SACC Manual A3062T (2018-12-06), Canadian Content Certification This procurement is conditionally limited to Canadian goods. Subject to the evaluation procedures contained in the bid solicitation, bidders acknowledge that only bids for items with a certification that the item(s) offered are Canadian goods, as defined in clause A3050T, may be considered.

5.1.2.1 Canadian Content Certification SACC Manual A3061T (2018-12-06), Canadian Content Certification

This procurement is conditionally limited to Canadian goods. Subject to the evaluation procedures contained in the bid solicitation, bidders acknowledge that only bids with a certification that the good(s) offered are Canadian goods, as defined in clause A3050T, may be considered.

Failure to provide this certification completed with the bid will result in the good(s) offered being treated as non-Canadian goods.

Due to the constrained time frame of this RFI a swift response would be appreciated.

Answer #2:

A future procurement would be conditionally limited to Canadian goods.

This means that the evaluation team would determine if there are two or more bids with a valid Canadian Content certification with the bids coming from two or more bidders that are not affiliated within the meaning used in the Competition Act, R.S.C., 1985, c. C-34. In that event, only those bids with a valid certification will be eligible to be awarded a contract; otherwise, all

bids will be eligible. If at any point in the evaluation process it is found, whether by determination of invalidity of certifications, determination that bids are non-responsive or withdrawal of bids by bidders, that there are no longer two or more responsive bids with a valid certification, then all responsive bids will be eligible to be awarded a contract. Please refer to Section 4.1(c) of the draft RFP (Attachment ABES.PROD.PW__BM.B030.E27579.ATTA002.PDF).

(2) Amendment 002 of the RFI

Attachment ABES.PROD.PW__BM.B030.E27579.ATTA002.PDF (draft RFP) is hereby amended as follows:

- Delete paragraph **1.2.3** in its entirety and replace it with:

The requirement is subject to a preference for Canadian goods.

- Delete paragraph **5.1.2.1** in its entirety and replace it with:

This procurement is conditionally limited to Canadian goods.

Subject to the evaluation procedures contained in the bid solicitation, bidders acknowledge that only bids for items with a certification that the item(s) offered are Canadian goods, as defined in clause [A3050T](#), may be considered.

Failure to provide this certification completed with the bid will result in the item(s) offered being treated as non-Canadian goods.

Bidders must clearly identify which items meet the definition of Canadian good and complete the certification below.

The Bidder certifies that:

() the item(s) offered and identified as Canadian goods are Canadian goods as defined in paragraph 1 of clause [A3050T](#).

- Delete paragraph **5.2.3.1** in its entirety.

The French version of the document is further amended to address a discrepancy. Such amendment is not necessary for the English version nor does it affect the English version.
