1	The Statement of work doesn't mention anything about containment, are there any permits required to carry out this power washing of the underwater hull while she is alongside at the coast guard base at Huron Street?	Please note that the contract will be carried out at the Institute of Oceans sciences, 9860 West Saanich road, Sidney, BC. (On Patricia Bay, at the west end of Victoria International Airport).
2	In order to comply with section 7.14 of the Invitation to tender; has special permission been made or will there a be requirement for the contractor to obtain permitting from the Department of Fisheries And Oceans, Ministry of Environment or other governmental agencies to perform the scope of work outlined in the specification. Specifically, the alongside vessel cleaning of the underwater hull, appendages, and propulsion in a restricted harbour without containment measures in place. Also, can Canada confirm that no ablative hull coatings that would pose risk to the environment are present on the CCGS Bartlett.	Canada has conducted a pre-inspection of the underwater hull. Due to the lack of marine growth found, Canada has removed the requirement for the underwater hull cleaning portion of the statement of work.
