AMENDMENT 001

Amendment 001 is raised to answer the questions below:

QUESTION 1:

Please confirm that no pricing for travel has to be allowed for at time of bid by the contractors?
Please also confirm that the owner will be paying for travel expenses? (Flights)

ANSWER 1:

There is a \$20,000.00 provision for travel for each year of the standing offer. It is included in Appendix 1 – Basis of Payment Pricing Table.

Each time a call-up is issued the contractor will follow the Federal Government Travel Regulations for travel costs. This would be added to the labour and material cost.

1.2 Measurement of Payment .2 Travel – will be paid for as per Federal Government Travel Regulations at time of travel. Details of expense claims to be broken down daily, showing departure and arrival times, meals, incidentals and accommodations on the invoices. A provisional amount of \$60,000.00 will be included in total bid price.
