Question 20:

If the bidder is in the process of application for security clearance as per the requirement of 6.1(a) and 7.3.1 but not in possession of this clearance at the time of the proposal submission, will the bid be considered non responsive?

Answer 20:

Yes. At date/time of bid closing, bidders MUST provide, within their bid package, supporting documentation to demonstrate that they meet ALL security requirements as outlined in Part 6 and Part 7 of the RFP. Failure to demonstrate security compliance, at date/time of bid closing, will render the bidder non-compliant and they will not be considered further.

Question 21

The RFP language stipulates a requirement for secret clearance at closing of this bid. Based on the equipment identified in the RFP document it appears none of it is proprietary to the military and can be obtained through open market. With that in mind, can this condition be either waived or deferred allowing others to bid on the prescribed work?

Answer 21

No, secret clearance cannot be waived. Several factors require a security clearance at closing of the bid:

- 1) Access to DRMIS is restricted to Secret cleared personnel;**
- 2) Access to DND facilities for pick-up, delivery or on-site calibrations may require Secret clearance;**
- 3) There are a number of instruments on the MIL that are classified as Demilitarization Code D and thus fall under the Controlled Goods Program; and**
- 4) Any facility that stores TMDE overnight must obtain a Facility Security Clearance.**

Question 22

I have a follow-up question to the following Question and DND response:

Question 14: *annex A – Statement of Work Appendix 13, Calibration Certificates and test data sheets; 1) a statement that the calibration meets the requirement of ISO 17025". Does this mean that each calibration must be an accredited 17025 calibration which includes a traceability statement as well as measurement data and uncertainty data for each parameter tested during the calibration or does it refer only to the general requirements for the competence of testing and calibration laboratories?*

Answer 14: *Each calibrations must be an accredited ISO 17025 calibration. All calibrations must meet the requirements of ISO 17025 and each individual calibration must include a traceability statement as well as measurement data and uncertainty data for each parameter tested during the calibration.*

Follow-up question: In the event that an Accredited 17025 calibration cannot be provided, what level of calibration will be acceptable and can be priced for DND as part of the bidder responses?

Answer 22

Please refer to the answer provided for question 14 (Each calibrations must be an accredited ISO 17025 calibration). In the event that a bidder cannot provide an ISO 17025 Calibration Accreditation for a particular calibration, the bidder MUST provide written supporting documentation from the OEM, at date/time of bid closing, which states that said accreditation does NOT exist.

Answer 23
