THIS AMENDMENT IS RAISED TO RESPOND TO BIDDERS' QUESTIONS

Reference: *Volume 1 – Part 4, Attachment 2A, Description of the Area Detection and Identification System (ADIS) bid evaluation laboratory test*

- Q9 Under Setup, the ADIS mandatory detection level for sarin is given as a column density of 135 mg/m²". What is base for this number? This requirements is 20 years old and we strongly advise against procurement with 20 year old requirement of equipment that should be in operation for next decades.
- A9 The requirement reflects the current NATO standard and is the *minimum* detection level required. Bidders will be evaluated based on the actual performance.
- Q10 The Testing procedure described is suitable for passive stand-off detectors, but not for active stand-off detectors, thus a different procedure should be defined.
- A10 Understanding that different products would require different test procedures, and in the interests of fairness and equal treatment, it was determined that the test procedure identified is best suited for the evaluation.
- Q11 Regarding point 6.3, do we have to have the DOS (VOD) at the moment we send you our quote? Or can we obtain it after in case we win? We have checked in the website that we have to be sponsored, is that something you can do?
- A11 The Security Clearance is not required at time of bid closing, but must be achieved prior to contract award. PSPC will sponsor any organization wishing to bid on this solicitation. A email request is all that is required to start the process. A Request for Private Sector Organization Screening (PSOS) will be forwarded to you shortly.
