Amendment 1 is raised to publish questions and answers:

Q1. Will the shipping location be able to accommodate a 53 foot trailer for the delivery of the goods? If not, what is the maximum truck length the location is able to accommodate?

A1. The Shipping and Receiving area cannot accommodate a 53 foot trailer. The maximum truck size is a 5-ton, which is equivalent to 22 – 26 foot moving truck.

Q2. Under Bid Evaluation, Hard Copy is checked off. However, there is an Epost Connect service included. Could you please confirm Epost submissions are also acceptable?

A2. Yes, epost Connect Service submissions are accepted. Bidders need to setup an epost Connect conversation with PWGSC Bid Receiving Unit by using the email address provided in the solicitation document.

For further information on epost Connect Services, bidders are to reference the SACC clause 2003 Standard Instructions – Goods or Services – Competitive requirements.

epost Connect Service would allow a bid to be submitted as a softcopy.

Q3. Are email or fax submissions to fax number: (819) 997-9776 acceptable?

A3. An email submission is not accepted, the epost Connect Service would have to be used. Yes, fax submissions are still acceptable. Bids must be faxed to the following number 819-997-9776 for bidders in National Capital Region (NCR).
