Question 9:

We would like to formally request a two-week extension in the RFI deadline.

Answer 9:

The deadline to submit responses to the RFI is extended to 27 February 2020.

Question 10:

Would you please provide additional details regarding the current use of deployment payment? For example, how is geographical risk factored in the payment (if at all), when is it triggered and paid, is it paid to employees or is it meant to cover additional company costs? We also request that Canada provide information on the terms and conditions of this payment.

Answer 10:

The payment is a set amount of \$200 for both foreign and domestic travel. The differentiating factor is that the domestic payment is paid for periods greater than 48 hours and the foreign payment for periods greater than 24 hours. The purpose of this payment is to pay for additional costs associated with travel, for example overtime.
