A. QUESTIONS AND ANSWERS

Q1: Is a bid bond required for the above captioned project? I understand that bonds are required when the estimated value is above \$100,000, but I'm unsure of who's estimate that is based on, whether it be our price or Parks Canada.

For example, I noticed on the buyandsell.gc.ca website that the estimated value is less than \$100,000, but if GMP's estimated price is above \$100,000, does that mean a bid bond is required?

Q2: The information on Buy and Sell is to provide potential bidders a sense of the dollar value of the requirement in order for them to determine if it is in their interest to submit a bid. The information indicated in the Invitation to Tender takes precedence over the Notice of Propose Procurement.
