SOLICITATION AMENDMENT No. 001

This solicitation amendment No. 001 is raised to:

- 1) Publish questions and answers that have been received in relation to this solicitation; and
- 2) Amend the solicitation.

- 1) The following Questions and Answers have been provided:

QUESTION 1:

"On page 31 section 11.2 uses cubic feet and with the Annex B basis of payment the storage rate term is Square feet. I would presume we will be using the square feet term?"

ANSWER 1:

In section 11.2 is should read square feet. Corrections will be made through Solicitation Amendment 001.

QUESTION 2:

"For the mandatory requirement we can always add extra information ie site supervisors?"

ANSWER 2:

You can add extra information. The mandatory requirements will be evaluated on what is being asked for in each criteria.

QUESTION 3:

"The points rating system for the mandatory requirements doesn't actually add up to 69. I think there is a typo in R7 that the sum is 2 and maybe should be 6. The wording does not have points value each for a maximum of ? I think I would read "2 points each for a maximum of 6" for the grand total of 69?"

ANSWER 3:

R7 only allows for a maximum of 2 points which equals a total of 65 points. Corrections will be made through solicitation amendment 001.

- 2b. At Annex A, of the request for standing offer, "**Statement of Work**",

Delete: Article 11.2, in its entirety; and

Insert: The following services also form part of the warehousing services: create, provide and maintain a computerized inventory of all equipment and/or furniture stored, and spelling out the total amount of square feet of actual material warehoused. Information to be kept includes, but is not limited to, quantities, physical location of item and detailed descriptions of items.

- 2c. At Part 4, of the request for standing offer, "**Evaluation Procedures and Basis of Selection**",

Delete: Article 4.4(a), in its entirety; and

Insert: To be declared responsive, an offer must:

-
- (i) comply with all the requirements of the Request for Standing Offer (RFSO);
 - (ii) meet all mandatory technical evaluation criteria; and
 - (iii) obtain the required minimum of 45.5 points overall for the technical evaluation criteria which are subject to point rating.

2d. At Annex F to Part 4, of the request for standing offer, "**Mandatory Technical Evaluation Criteria**",

Delete: Article 2 – Point Rated Criteria, in its entirety; and

Insert: Article 2 – Point Rated Criteria (Revision 1). (see below)

2. Point Rated Criteria (Revision 1)

The point rated criteria will be used to evaluate each offer that has met all of the mandatory criteria. Offeror's are advised to address each of the criteria in the order in which they appear and in sufficient depth in their offers to enable a thorough assessment. Assessments will be based solely on the information contained within the offer.

Only those offers which are responsive (compliant) with all of the mandatory criteria and then achieve (or exceed) the stated minimum points required for the point rated technical criteria section will be further considered for issuance of a RMSO. Offers not meeting the minimum points required will be deemed non-responsive.
