Amendment 001

This amendment is being raised to answer industry questions:

QUESTIONS AND ANSWERS

- Q1.** Is the delivery time fixed for all the barges or can delivery schedules be proposed? Does CCG need all barges by late summer 2021, or can some barges be delivered, for example, by late summer 2022? If yes, what is the quantity required by late summer 2021?
- A1.** Should Canada choose to proceed with a follow-on solicitation (Request for Proposal) for the acquisition of 20 m³ and 40 m³ aluminum barges, delivery schedules may be proposed in a Contractor's bid, however delivery of all barges is required by no later than December 31, 2021.
- Q2.** Is CCG willing to register more than one barge together if the proposed design is modular? For example, is it acceptable for 6 -7 modules of 20 m³ to be registered together, but used separately as required by CCG?
- A2.** Should Canada choose to proceed with a follow-on solicitation (Request for Proposal) for the acquisition of 20 m³ and 40 m³ aluminum barges, the current requirement is for all barges to be registered separately and may not be modular. However, based on the feedback received from industry through this RFI process, Canada's requirement is subject to change.
