This solicitation amendment 001 is hereby issued to address questions by industry.

Q1: We would like to know if you can kindly provide the number of the port visits made in the 6 ports listed at Appendix A2 over the last 3 years, in order to have an historical reference to be used as rough estimate.

A1: North Vancouver, British Columbia : 3 Visits over past 3 years
Vancouver Harbour, Vancouver, British Columbia: 3 visits over past three years
Nanaimo Harbour, Nanaimo, British Columbia: 3 Visits over past 3 years
Ogden Point/ Breakwater District, Victoria, British Columbia: 2 visits over past three years
Prince Rupert, British Columbia: 0 Visits over past 3 years
Powell River, British Columbia: 0 visits over past 3 years

Q2: We would like to know if you can kindly provide the estimated total value of the Contract.

A2: The contract is expected to include a ceiling price of \$ 245k (GST excluded) for the firm work period, and \$245k (GST excluded) for the one-year option period.

Q3: At Annex E, "Electronic Payment Instruments", it does not appear the option "Wire Transfer (International Only)", usually appearing on similar RFSOs. Can you kindly evaluate the possibility to add that option too?

A3: Wire Transfer (international only) can be offered. Note Electronic Payment Instruments are not evaluated upon.
