- Perform work in accordance with the most current National Plumbing Code of Canada, Canadian

Electrical Code, CSA B139 code, and any other provincial or Federal codes related to the work being carried out.

- All work must follow Workers Compensation Board and Municipal Statutes, Canada Labor code,

Provincial and Federal Health and Safety Act.

- Lock out/tag out all live equipment during servicing of equipment.
- Any hot work requires an AAFC Hot Work Permit.
