AMENDMENT 005

This amendment is issued to answer an additional question from suppliers. Due to time constraints, the bid closing date will not be extended.

Question 1: I have found a discrepancy while completing the price grid between the initial term and the various optional years:

- In Annex B, basis of payment, for the section B.1.x.2.j Application Forms Insert, there are discrepancies between the initial term and the various optional years, please advise:
 - The descriptions are not always the same, sometimes being '17" x 11" folded: 8.5" x 11", then 8.5" x 3.666" Print 2/2 - Optional product', some other times being '8" x 8", 4" x 8" folded Print 2/2'
 - **For the second option period the section is appearing twice, which will affect the total for this period.**

Answer 1: The description in the SOW is correct as well as the description for B.1.1.2.1.j (2 year contract)

The description for B.1.2.2.j, B.1.3.2.j and B.1.4.2.j (option years) in Annex B - Basis of Payment is incorrect.

Due to time constraints, the solicitation will not be amended. In the interest of fairness to all bidders, pricing for this line item will not be evaluated for any of the option periods.

ALL OTHER TERMS AND CONDITIONS OF THE BID SOLICITATION REMAIN UNCHANGED
