The purpose of this revision to the Request for Standing Offers (RFSO) is to answer questions from potential bidders.

Question 1

I am trying to download the curriculum in French, but I keep getting an error message.

Answer 1

The files "appendix 5-french curriculum" and "appendix 6-english curriculum" are very large files that can take several minutes to download. It is recommended that you save the file rather than opening it directly from the Buy and Sell website.

Question 2

Very briefly, are you looking for suppliers to deliver specific content to the military or are you looking for suppliers with B and C level training expertise?

Answer 2

DND requires language training services aimed at providing second language training (French and English) to its members (primary military but may include civilians employees) using the Canadian Armed Forces curriculum. The expertise for teaching levels A, B and C of the offeror will be assessed according to the mandatory and rated criteria which can be found in the RFSO.
