- 1) The following Question and Answer has been provided:

QUESTION 1:

In the case of a location /district where there is an aboriginal SO and a non-aboriginal SO established, each containing one qualified offeror, what method will the Crown apply at the call-up stage for the requirements in that location / district when project work is requested?

ANSWER 1:

A Regional Master Standing Offer (RMSO) is a standing offer issued for the use of many departments or agencies within a specific geographic area.

It is PWGSC's intent to provide their clients with an aboriginal RMSO and a non-aboriginal RMSO for moving services. In the event there is a location with both an aboriginal and non-aboriginal RMSO, clients will determine which RMSO to use based on their own operation requirements.
