## **PART 1 - GENERAL INFORMATION**

### **1.1 Requirement**

The requirement is detailed under Annex A of the resulting contract clauses.

### **1.2 Debriefings**

Bidders may request a debriefing on the results of the bid solicitation process. Bidders should make the request to the Contracting Authority within 15 working days from receipt of the results of the bid solicitation process. The debriefing may be in writing, by telephone or in person.

### **1.3 Trade Agreements**

The requirement is subject to the provisions of the North American Free Trade Agreement (NAFTA), and the Canadian Free Trade Agreement (CFTA).

### **1.4 epost Connect service**

This bid solicitation allows bidders to use the epost Connect service provided by Canada Post Corporation to transmit their bid electronically. Bidders must refer to Part 2 entitled Bidder Instructions, and Part 3 entitled Bid Preparation Instructions, of the bid solicitation, for further information.

## **PART 2 - BIDDER INSTRUCTIONS**

### **2.1 Standard Instructions, Clauses and Conditions**

## 2.3 Enquiries - Bid Solicitation

All enquiries must be submitted in writing to the Contracting Authority no later than five (5) calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by Bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the question(s) or may request that the Bidder do so, so that the proprietary nature of the question(s) is eliminated, and the enquiry can be answered to all Bidders. Enquiries not submitted in a form that can be distributed to all Bidders may not be answered by Canada.

## 2.4 Applicable Laws

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in Nova Scotia.

Bidders may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their bid, by deleting the name of the Canadian province or territory specified and inserting the name of the Canadian province or territory of their choice. If no change is made, it acknowledges that the applicable laws specified are acceptable to the Bidders.

## PART 3 - BID PREPARATION INSTRUCTIONS

### 3.1 Bid Preparation Instructions

- If the Bidder chooses to submit its bid electronically, Canada requests that the Bidder submits its bid in accordance with section 08 of the 2003 standard instructions. The epost Connect system has a limit of 1GB per single message posted and a limit of 20GB per conversation.

- If the Bidder chooses to submit its bid in hard copies, Canada requests that the Bidder submits its bid in separately bound sections as follows:

If there is a discrepancy between the wording of the soft copy on electronic media and the hard copy, the wording of the hard copy will have priority over the wording of the soft copy.

- If the Bidder is simultaneously providing copies of its bid using multiple acceptable delivery methods, and if there is a discrepancy between the wording of any of these copies and the electronic copy provided through epost Connect service, the wording of the electronic copy provided through epost Connect service will have priority over the wording of the other copies.

Prices must appear in the financial bid only. No prices must be indicated in any other section of the bid.

Canada requests that bidders follow the format instructions described below in the preparation of hard copy of their bid:

- (a) use 8.5 x 11 inch (216 mm x 279 mm) paper;
- (b) use a numbering system that corresponds to the bid solicitation.

In April 2006, Canada issued a policy directing federal departments and agencies to take the necessary steps to incorporate environmental considerations into the procurement process [Policy on Green Procurement](https://www.tbs-sct.gc.ca/pol/doc-eng.aspx?id=32573) (https://www.tbs-sct.gc.ca/pol/doc-eng.aspx?id=32573). To assist Canada in reaching its objectives, bidders should:

- 1) use 8.5 x 11 inch (216 mm x 279 mm) paper containing fibre certified as originating from a sustainably-managed forest and containing minimum 30% recycled content; and
- 2) use an environmentally-preferable format including black and white printing instead of colour printing, printing double sided/duplex, using staples or clips instead of cerlox, duotangs or binders.

## PART 4 - EVALUATION PROCEDURES AND BASIS OF SELECTION

### 4.1 Evaluation Procedures

- (a) Bids will be assessed in accordance with the entire requirement of the bid solicitation including the technical and financial evaluation criteria.
- (b) An evaluation team composed of representatives of Canada will evaluate the bids.

#### 4.1.1 Technical Evaluation

##### 4.1.1.1 Mandatory Technical Criteria

Bidders must clearly demonstrate compliance with each mandatory technical criteria outlined in Annex “C”. Failure to demonstrate compliance will result in the bid being deemed non-responsive, and be given no further consideration.

#### 4.1.2 Financial Evaluation

The price of the bid will be evaluated in Canadian dollars, Applicable Taxes excluded, FOB destination, Canadian customs duties and excise taxes included.

### 4.2 Basis of Selection

A bid must comply with the requirements of the bid solicitation and meet all mandatory technical evaluation criteria to be declared responsive. The responsive bid with the lowest evaluated price will be recommended for award of a contract.

## PART 5 – CERTIFICATIONS AND ADDITIONAL INFORMATION

Bidders must provide the required certifications and additional information to be awarded a contract.

The certifications provided by Bidders to Canada are subject to verification by Canada at all times. Unless specified otherwise, Canada will declare a bid non-responsive, or will declare a contractor in default if any certification made by the Bidder is found to be untrue whether made knowingly or unknowingly, during the bid evaluation period or during the contract period.

The Contracting Authority will have the right to ask for additional information to verify the Bidder's certifications. Failure to comply and to cooperate with any request or requirement imposed by the Contracting Authority will render the bid non-responsive or constitute a default under the Contract.

## **5.1 Certifications Required with the Bid**

## ANNEX "A" REQUIREMENT

The Mainland Nova Scotia Field Unit (MNSFU) of Parks Canada is looking to purchase a single axel trailer with a modular interior that can perform five separate functions. It should be able to act as:

- 1) a mobile kiosk and information booth
- 2) a space for small scale programs and information sessions
- 3) a sleeping space for two people
- 4) a secure and welcoming space for any members of the public who need to get out of inclement weather
- 5) a storage space

In order to meet all of these needs, the MNSFU is looking for a trailer with the following mandatory requirements:

### **Modular Interior:**

- In this context, modular means that any furniture, such as a chair, table, or bed, should be able to be repositioned within the interior to meet different needs. It is also mandatory that any of these furniture items be able to be removed from the trailer completely when not required.
- The modular system must have a configuration that can seat at least four people.
- The modular system must have a configuration that can sleep at least two people.
- To maximize space, the trailer does not need a washroom or kitchenette; **designs that include these elements will not be considered.**

### **Doors:**

- Two doors are required; one side door and a back door or hatch that can open and be used as an exit or as a convenient way to access the trailer if it is being used for storage.
- The dimensions for the side door opening must be at least 56 inches high and at least 28 inches wide.
- The rear door opening must be at least 50 inches wide and 49 inches high.

### **Trailer Dimensions:**

- The trailer is to be between ten (10) and fourteen (14) feet in length, not including the tongue.
- The trailer is to have a width of at least six feet, six inches (6'6") on the inside.
- The height from the floor to the ceiling on the inside of the trailer must be at least six (6) feet.

**Weight:**

- The dry weight of the trailer must not exceed 2,000 lbs.
- The Gross Vehicle Weight Rating must be at least 3,500 lbs.

**Windows:**

- There must be at least one (1) window on each side of the trailer, not including any window that may already be included in the door. Designs that include additional windows are welcome, but not necessary.
- The window on the side of the trailer that does not contain the door must be able to open and provide an opening that is at least thirty (30) inches wide and twenty (20) inches tall; this is necessary to help the trailer serve as a kiosk or information booth.

**Floor:**

- The floor of the trailer needs to be easy to clean with a broom or mop, therefore smooth floor coverings like linoleum, fibreglass, epoxy finishes or similar products are required.
- Floor coverings made of unfinished plywood or carpet will not be considered.

**Exterior:**

- The exterior sides of the trailer must be smooth, so that they can be easily wrapped with Parks Canada images after purchase.
- The exterior must be light in colour. Dark colours will not be accepted, as the trailer needs to be wrapped with Parks Canada images and dark colours will change the appearance of the wrapping.

**Canada Motor Vehicle Safety Standards (CMVSS):**

- The trailer will be employed on Canadian roadways, as such it must meet the Canada Motor Vehicle Safety Standards as directed by Transport Canada.
