This Amendment #003 is raised to respond to bidder question.

- Q1:** Can you please confirm line item 4 Site Facilities Operations of 6 weeks in Unit Price Table given that Section 01 52 00 1.1.2 states that Site Facilities – Operation will be paid in accordance with lump sum price established to operate and maintain all infrastructure between mobilization and demobilization. Moreover, since all work must be performed by March 31, 2020, this only gives 4 weeks of work after contract award.
- A1:** Canada has identified that line item 4 - Site Facilities Operations states 6 weeks in Unit Price Table, however; based on the anticipated award date all work under the contract, once awarded, shall be completed by March 31, 2020. Bidders shall not consider the 6 week duration in line item 4 Site Facilities Operations in the Unit Price Table for their bid.

All other terms and conditions remain unchanged.
