**Question #020:**

Could Canada provide an extension to the bid closing date?

**Answer #020:**

Canada grants an extension of the bid closing date. The new bid closing date is **March 9, 2020**. Please note that in view of the schedule for CIPO ITM, Canada has no intention to further extend the bid closing date.

**Question #021**

**Question #021:**

Based on Answer #016 in Amendment #007, we require clarification on the definition of total contract duration. Please confirm that by total contract duration Canada means the duration from the start date to the end date for the awarded contract. For example, Canada had awarded a contract with a start date of September 2017 and the contract ended on August 2019. In this case, the total contract duration is 24 months. Is this consistent with Canada's definition of contract duration?

**Answer #021:**

Yes, the above is consistent with Canada's definition of contract duration.

As further clarification to Question #016 in Amendment #007, please note the following. To determine the duration of the reference contract(s) the Bidder provides in response to CPR-9, Canada will measure from the start date of the reference contract to the end date of the reference contract. In other words, to determine whether the requirement under section III, part (e) of CPR-9 is met, Canada will measure from the start date of the reference contract to the end date of the reference contract and will not limit the duration measurement to only those periods of the reference contract for which procurement support was provided.

**Question #022:**

Could Canada provide an example of the calculation of contract duration?

**Answer #022:**

Yes, an example is provided below.

If Canada awards a contract on April 15, 2020 with an initial contract period of two (2) years and irrevocable options to extend the duration of the Contract by up to three (3) additional one (1) year period(s), then:

- If Canada decides not to exercise the option periods, the duration of the contract would be from April 15, 2020 to April 14, 2022 (i.e. twenty-four months);
- If Canada decides to exercise the first option period, the duration of the contract would be from April 15, 2020 to April 14, 2023 (i.e. thirty-six months);
- If Canada decides to exercise the second option period, the duration of the contract would be from April 15, 2020 to April 14, 2024 (i.e. forty-eight months); and
- If Canada decides to exercise the third option period, the duration of the contract would be from April 15, 2020 to April 14, 2025 (i.e. sixty months).

The Contract duration is the time elapsed between the start date of the contract and the end date of the contract.
