1	<p>Refers to Technical Evaluation Criteria section 1,0 Mandatory Technical Criteria M1 and M2:</p> <p>It is stipulated that Bidder must clearly describe two Projects Delivery Experience it has completed within the last five years, one in Canada and one outside of Canada to clearly demonstrate the international scope and experience of Bidder.</p> <p>It also stipulates projects will not be accepted in cases where the work was performed by one or more of the bidder's key team members on behalf of another firm.</p> <p>Could a Bidder be able to include in it's proposal one project produced by both key team members while with another firm that has ceased operations in the event management field? Said previous firm would give consent to both key team members and Bidder for the use of said project in this RFP.</p> <p>For further information, this type of modification was made and granted on a previous Government of Canada RFP. We would also include a consent letter from the previous firm with our proposition.</p>	<p>In the event that all key members of the bidder's team have been involved in a production with another company who approves them to submit this project as part of the request for proposal for the Canada's Cultural Program at Expo 2020, it would be permitted to submit such a project to clearly demonstrate the bidder's national and international scope and experience.</p>
2	<p>Refers to Solicitation closing period.</p> <p>Due to complexity of the project within an International Fair, could the closing date be extended of one week for the preparation of our proposal?</p>	<p>The Government of Canada will add 7 days to the Request of proposals.</p>
