Questions and Answers

Question #1: Can cells within a stockpile which fail for HW Copper be placed upon cells failing for HW Lead during segregation of the CL+ cells?

Answer #1: Soil movement/soil segregation can be considered but no additional compensation will be made to the contractor should they choose to multi-handle material after contract award.

Question #2: Will all amended HW soils be stockpiled within the onsite storage shed?

Answer #2: No.

Question #3: Can HW cells within a stockpile be removed and stored in another HW containing stockpile in order to segregate CL+ cells for disposal?

Answer #3: Soil movement/soil segregation can be considered but no additional compensation will be made to the contractor should they choose to multi-handle material after contract award.
